The U.S. Supreme Court on Thursday upheld a provision of the National Labor Relations Act that prevents an employer from firing an employee for, or disciplining or threatening to discipline, an employee for "protected concerted activity" on behalf of a co-worker. In a split decision, the court ruled 5-4 that an employer who threatens to discipline an employee for protected concerted activity will be permitted to discipline the employee. The provisions were part of a broader overhaul of the National Labor Relations Act (NLRA) in 1935 that enabled union members to organize more effectively and authorized the NLRB to oversee labor-management relations.
