fenner and davis maintain the grand juror's questions meant to elicit testimony regarding the positive field test results, they argue the falsity of that testimony prejudiced them because it implied the case agent lied in answering the question. however, there is no evidence the prosecutor knew the grand juror had asked the guestion at all, much less that it referred to the field tests. fenner and day is also contend that the prosecutor misrepresented their answers, they point to several places in the transcript where they responded in the affirmative to the question, but the prosecutor's interpretation of the defendants' answers was the correct one: while the defendants agreed the substances had been tested, they disagreed with the case agent's conclusion that the substance was in fact fentanyl, fenner and davis next contend that the government committed a pattern of deliberate misconduct by, among other things, offering expert testimony in a manner which implied the defendants' quilt; basing the testimony in part on improper hearsay evidence; and making knowing misstatements to the grand jury. 9 we review the district court's findings of deliberate prosecutorial misconduct for clear error and the constitutional due process violation de novo. kimbrough, 552 u.s. at 96, 128 s.ct. 558. even if the misconduct is deliberate, it will justify habeas relief only if it caused the defendant substantial prejudice. hayes, 518 f.3d at 964. we address each of the alleged instances of misconduct in turn, fenner and davis object to the testimony of two dea agents and an fbi agent regarding various controlled buy incidents that were investigated by other drug enforcement agencies, one dea agent who worked on the fentanyl investigation testified that he did not personally investigate each of the buys but instead relied on the agents who did. he said the case agent who conducted the controlled buys in this case was not present during the transactions and the agent who did was. another dea agent testified that the case agent "wasn't there" when the buys were conducted but another dea agent was present and conducted them. the defense did not object to the testimony at trial, and we generally do not address issues raised for the first time on appeal. united states v. aldridge, 561 f.3d 759, 765 (8th cir.), cert. denied, 558 u.s. 983, 130 s.ct. 427, 175 l.ed.2d 270 (2009), fenner and davis did object to the testimony on appeal, so we review for plain error, no objection was lodged to the second dea agent's testimony about the controlled buys, even if the testimony was plainly erroneous, it did not rise to the level of plain error. fenner and davis were not substantially prejudiced by the testimony because the case agent testified he was present during most of the controlled buys, and he did not rely solely on his law enforcement colleagues but was himself involved in the investigation. 10 see united states v. brandon, 521 f.3d 1019, 1022 (8th cir.2008) (stating that "even if the government's closing argument was improper, we cannot conclude the defendant was substantially prejudiced," where the agent testified at trial that he had conducted the controlled buys and controlled amounts of narcotics were seized); hayes, 518 f.3d at 964 (holding there was no plain error where the trial testimony and closing argument of the agent in charge of the investigation substantially corroborated the informant testimony).
